

# Open Call: MICC Workshop Facilitator

## with focus on human rights, international law and climate justice

The MICC team is seeking skilled and experienced trainers to lead workshops in the framework of the **MICC event hub 2025: Model International Criminal Court - Human Rights Education Still Matters!** All activities will take place from **June 10th to June 18th, 2025**. We are looking for external speakers for workshops that provide insights into the fields such as human rights, international law, and climate justice.

### About us:

For 35 years, the Kreisau-Initiative has been actively promoting exchange among young people and multipliers in Europe and beyond. In doing so, it builds a bridge between remembrance work and current development policy goals in the field of non-formal education.

This project takes place on the occasion of the 20th anniversary of the Model International Criminal Court (MICC) – a participatory educational program that has successfully engaged young people from Europe and around the world in simulated court trials of international criminal cases since 2005.

The anniversary year offers an opportunity to reflect on the program's impact, address current challenges, and continue developing human rights education with a forward-looking perspective.

### Project overview:

The **MICC Alumni Meeting (June 9–15, 2025)** brings together young people who have participated in formats such as MICC School or MICC University over the past ten years.

This gathering and networking opportunity strengthens their role as active members of civil society and provides access to a broad network as well as to decision-makers from politics, civil society, and academia. The focus is on climate- and human rights-related topics such as the protection of the right to protest, dealing with environment-related human rights violations, and strengthening resilience to confront discriminatory discourse and forms of hate speech with civic awareness, legal knowledge, and confident, reflective action.

The **MICC Experts Training (June 13–19, 2025)** brings together experienced professionals and advanced students in the fields of law, international relations, political science, and journalism who are interested in deepening their understanding of international criminal justice and gaining practical skills in simulated legal proceedings.

This gathering and networking opportunity strengthens their role as active members of civil society and provides opportunities to broaden their network to decision-makers from legal fields, politics, civil society, and academia. The focus is on reflecting and discussing international criminal law, combining it with climate- and human rights-related topics, including ecocide, as well as strengthening the MICC's connection to the Global South.

## Scope of work and responsibilities:

- For Alumni Meeting
  - Lead a 4-hour workshop (flexible timing between June 10–12)
  - Target group: approx. 80 participants, young people who have participated in formats such as MICC School or MICC University over the past ten years, aged 18–25
- For Experts Training
  - Lead a 4-hour workshop during the Experts Training (flexible timing between June 16–18)
  - Target group: approx. 40 participants
  - experienced professionals and advanced students in the fields of law, international relations, political science, and journalism

### General Responsibilities

- Prepare workshop content tailored to the themes of human rights, international law, and climate justice
- Use innovative and interactive methods to engage participants
- Coordinate in advance with the organizing team (including attending an online meeting)
- Conduct the workshop and, if necessary, support follow-up activities or documentation

## Requirements / Profile:

We seek candidates with the following qualifications and experience:

### 1. Content Requirements

- Expertise in one of the following fields: human rights, international law, or climate justice
- Ability to create a clear connection between the workshop content and the MICC program

### 2. Experience with groups:

- Demonstrated experience in planning and facilitating workshops or training sessions for groups of at least 40 participants.
- Proven ability to manage group dynamics, maintain engagement, and handle logistical challenges in large group settings.
- Skilled in designing and leading ice-breaker activities and interactive group sessions

### 3. English Language Proficiency:

- Excellent command of the English language.
- Ability to facilitate group discussions, give clear instructions, and produce concise reports or summaries in English.

### Additional Competencies (Preferred but not mandatory):

- Background in education, social sciences, youth work, or community development.
- Experience with cross-cultural or international groups is an asset.

Interested candidates should submit:

- A detailed CV highlighting relevant experience.
- Please submit a single page with a brief overview of your workshop idea.
- Financial work offer.
